### Step 1 - Determine Your Fair Share Membership Contribution.

Your Fair Share membership contribution is calculated by multiplying your **annual household income** by the applicable percentage from the table below, **or** it is \$250 if your household income is less than \$17,000, **or** it is \$50 if you are a full-time student, **or** it is at least \$200 if you are an associate (long-distance) member. **“Annual household income” is your adjusted gross income (AGI) for tax purposes (2023) Form 1040, page 1, line 11, plus tax exempt income.** Membership contributions are tax deductible. If it is within your means, we are asking members to generously consider donating an additional 10% to support us in our mission. Thank you for your support!

### Step 2 - Determine Tuition and Instructional Material Fees for Religious School.

Congregation members with children participating in Religious School will pay school fees in addition to the Fair Share membership contribution. Religious school tuition for members is \$450 per child, per year. The fee for books and other instructional materials for grades 4 / age 9 and up are \$100 per student. Tuition and instructional material fees are not tax deductible. School registration packets will be mailed in late summer.

### **Step 3 - Select Your Payment Method.**

The Synagogue sends statements quarterly during the July 1-June 30 fiscal year, with the first reminder in late July. Because of the need for operating revenue throughout the year, you must select one of four payment methods for your contribution and fees. Timely payment according to the selected payment method will assure full, uninterrupted privileges as a Member-in-Good-Standing. If you wish to change your payment method during the year, please contact the Synagogue office to make appropriate arrangements.

***Please Check One of these Payment Methods:***

- Monthly** - 1/12 each month from July through June
- Semi-annually** - 1/2 by July 31 and December 31
- Quarterly** - 1/4 by July 31, October 31, January 31 and April 30
- Payment in full** by December 31


You may pay for your dues & tuition, as well as donations, dinner events and other activities, using a credit card (Visa, Master Card & Discover) or by ACH debit transactions from your bank account. **Attached is an Authorization form for Automatic Credit Card or ACH Debits.** If a bank withdrawal or credit card payment was previously authorized it will continue, but please let us know if you need to change the amount. **If you choose to pay by credit card, please consider reasonably increasing your payments (3% to 5%) to cover the extra fees this form of payment imposes on the congregation.** We also accept payments via Venmo (@AgudasIC).

**Financial Assistance** It is the practice of Agudas Achim Congregation to support membership. We are committed to do everything reasonable for mutually acceptable financial arrangements. **No one is turned away due to financial hardship** that precludes paying the Fair Share dues contribution or religious school fees. All requests for special arrangements are kept in strict confidence.
