Attached is an Authorization for Automatic Debits. If a bank withdrawal or credit card payment was previously authorized it will continue, but please let us know if you need to change the amount. If you choose to pay by credit card, please consider reasonably increasing your payments (3% to 5%) to cover the extra fees this form of payment imposes on the Congregation.

We are committed to do everything reasonable for mutually acceptable financial arrangements. **No one is turned away due to financial hardship** that precludes paying the Fair Share dues contribution or religious school fees.
